ONGOING BUSINESS Budget

Executive Director Keiser presented the draft 2012 – 2013 MDF budget to the Jamestown Harbor Commission. He, along with Christina Collins, Finance Director, feels confident that the presented budget revenues can be met.

A discussion on the budget ensued.

Facilities

Town Engineer, Mike Gray, presented the Jamestown Harbor Commission with a revised version of the draft asset management plan. He requested the Jamestown Harbor Commission prioritize projects listed under "Capital Improvement Projects" and assign a monetary figure to them for the Long Range Infrastructure Plans.

After a discussion with Commissioner Brown, Mike Gray offered to provide the Jamestown Harbor Commission with a project list that already has estimates attached to the projects.

Mooring Implementation

Commissioner Cain had nothing to report.

Harbor Management Ordinance / Comprehensive Harbor Management Plan

Chairman deAngeli presented the Jamestown Harbor Commission with language to address the PATON regulations, per the Coast Guard, so the Harbormaster can enforce the Coast Guard regulations.

Chairman deAngeli moved to accept this amendment to the Harbor Management Ordinance and to pass on to the Town Council. Commissioner Brown seconded. So voted (4 ayes, 0 nays).
