VI. Old Business

1. Norton H. Reamer 2002 Trust – Plat 12, Lot 29 - Hull Cove Farm Rd. & Beavertail Rd.2 lot Minor Subdivision – Partial Release of Bond

Town Planner Lisa Bryer updated the planning commission and noted that they have met all the conditions of final approval. They are looking for a \$70,000 release of the original \$100,000 bond. The applicant would like to save the final grading until the spring. The water line has been completed and Wyatt Brochu has reviewed all the legal documents.

The TRC recommended the Planning Commission approve this on Monday December 15, 2014 after they reviewed it.

Mike Darveau said the water line has been installed (6 inch pipe, pressurized, chlorinated) The road has been rough graded. The plan was to put the line in and finish the road but because of some timing issues and the time of year right now they have decided to put it off until Spring. The Abutters have been consulted, along with <u>the</u> engineers it will be rough graded and some gravel put down. They have worked out a schedule with all involved including the Goodman's, whose home is being constructed currently. Mr. Clark, the excavator will come to replace the temporary shale fill in the road with appropriate gravel fill in between Christmas and New Years to do a pre final grade and will check on it throughout the winter before the final road is put in.

Commissioner Cochran asked about the fire hydrants, there are three new hydrants that have been installed. They have coordinated with the fire department. Who tests the water line Swistak asked? An outside company. Their engineer is responsible for signing off on the road, because it is not public it is up to them and Mike oversees it. Applicant has turned over the water line to the town. Wyatt said the applicant has provided the things needed.

There are only a few things left before the final \$30,000 is released and it does has to come before the planning commission. When they record the easement his opinion letter has to be brought up to date, suggested Wyatt Brochu.

Commissioner Pfeiffer made a motion that was seconded by Commissioner Pendlebury in the matter of Norton H. Reamer 2002 Trust - Plat 12, Lot 29 – Hull Cove Farm Road & Beavertail Road - 2 lot Minor Subdivision with a water line extension:

To accept the finding of the Technical Review Committee held December 15, 2014 which found the principal had met the requirements of the Preliminary Approval dated July 24, 2014. The Planning Commission authorized the Finance Director, Christina Collins to release \$70,000 of the \$100,000 guarantee and that \$30,000 is sufficient to cover the cost of remaining improvements.
