Minutes of the January 8, 2014 Meeting of the Jamestown Harbor Commission Amended: 2-12-2014 Approved: 2-12-2014

A meeting of the Jamestown Harbor Commission (JHC) was held Wednesday, January 8, 2014 at the Jamestown Town Hall, 93 Narragansett Avenue, Jamestown, Rhode Island.
