II. CALL TO ORDER

President Trocki referenced RIGL 42-46-5(a) Subsection (5) Real Estate and stated on May 19th (in open session) the Town Administrator was authorized to negotiate a Purchase and Sales Agreement for the property located at 2 Broad Street, described as Plat 1 Lot 311, a ½ acre lot adjacent to the town-owned Park Dock, subject to approval of a RIDEM Grant. The Purchase and Sales Agreement was signed on August 18, 2014. To date the Town has not heard about the grant award, and the original closing date of October 15th was postponed to November 15th, pending a successful RIDEM grant award. The Town's portion of the purchase price is not paid for with taxpayer dollars, but from subdivision application fees collected for the purpose of recreation and open space. If anyone has any questions they may speak with Town Administrator Nota.
