# TOWN COUNCIL MEETING June 8, 2015

# II. CALL TO ORDER, PLEDGE OF ALLEGIANCE

Council President Trocki called the regular meeting of the Jamestown Town Council to order at 5:03 p.m. in the Jamestown Town Hall Rosamond A. Tefft Council Chambers at 93 Narragansett Avenue, and Councilor Dickinson led the Pledge of Allegiance.

### **IV. PUBLIC HEARINGS, LICENSES AND PERMITS**

All approvals for licenses and permits are subject to the resolution of debts, taxes and appropriate signatures as well as, when applicable, proof of insurance.

A) <u>Council Sitting as the Alcoholic Beverage Licensing Board</u>

A motion was made by Vice President Meagher with second by Councilor White to convene as the Alcoholic Beverage Licensing Board at 5:04 p.m. President Trocki, Aye; Vice President Meagher, Aye; Councilor Dickinson, Aye; Councilor White, Aye; Councilor Tighe, Aye.

President Trocki noted issues with the application before the Council as the Fire Chief and Building/Zoning Official have not signed off on the application. Town Administrator explained the approval process and that officials will not sign the application until all required work is completed. Chief Bryer has not signed the application as the fire alarm system in the expansion is not complete.

Applicant's comments. Mr. Brayton commented on the process and asked if he could have applied for the liquor license expansion earlier. He was informed the liquor license application before the Council is the last phase and he is not late in the application process, but he is not in compliance as the fire alarm system is not complete and therefore not approved. President Trocki commented that the Council does not usually address applications until all signatures are in order.

Mr. Brayton commented the fire alarm should be complete in the next three or four days. He noted the statement that appears on the agenda under the heading of Public Hearings, Licenses, and Permits: "All approvals for licenses and permits are subject to the resolution of debts, taxes and appropriate signatures as well as, when applicable, proof of insurance." He asked the application be approved subject to those requirements.

Town Council comments. Councilor White commented he believes this could be approved subject to receipt of all approvals and signatures. Town Administrator Nota commented on Council policy that applications are not addressed until all signatures have been obtained, and President Trocki concurred. Councilor White believes it can be approved subject to all conditions being met. Discussion ensued of past practices and the reasons for holding all applications for proper signatures. President Trocki noted the Council has held firm to their policy out of respect for one Councilor's beliefs and to provide exemptions would be difficult. Mr. Brayton stated the Town has requirements in place to govern the approval process and it is a shame to be holding up economic benefits for the town.

President Trocki stated this was advertised for public hearing and placed on the agenda with the expectation all requirements would be met. Mr. Brayton explained his logic. Town Administrator Nota explained the approval and compliance procedures followed and that approval of the liquor license expansion is the last phase. commented he is not in favor of approving prior to all signatures in place so that no applications fall through the cracks, which could then fall back on the Council. It is up to the owner to be sure he has all things in place. President Trocki commented this special meeting was called to assist both businesses in town as a courtesy, and it is difficult being placed in this position.

Mr. Brayton stated he intends to follow the rules and wouldn't open until all conditions were met. Councilor Tighe prefers to continue this to the June 22<sup>nd</sup> meeting. Councilor Dickinson does not have anything to add. Vice President Meagher stated her support for the application before us. Councilor White commented he has no problem with approving subject to all appropriate signatures, he does not like to be arbitrary, to approve subject to does not set a precedence, and each application should be approved on its own merits. President Trocki commented on the dilemma, and Vice President Meagher concurred. Discussion ensued of the Council meeting schedule. Lengthy discussion ensued.

# A motion was made by Councilor White with second by Vice President Meagher to approve the expansion of use for Simpatico Jamestown subject to completion of the work and appropriate signatures received.

Public comments. Mike Swistak of Narragansett Avenue commented the Planning Commission is supportive of economic development, and if the Council waits until the 22<sup>nd</sup>, Simpatico could lose two weekends out of their short season. Building Official Brown and Police Chief Mello and staff, who pass this location numerous times daily, can recognize if the second story is in use prior to approval and alert the Council.

Council members comment the bigger issue is whether to continue the policy in place and all Council members are not in agreement. The Council strives to support economic development and the business community. Council may need to reevaluate the current policy. Councilor Tighe commented it is his feeling the applicant has the responsibility to get the application complete and he does not want to approve it until the application is complete. Town Administrator Nota stated the normal process is not to place an incomplete application on the agenda, but in this case, this was advertised for public hearing by Council vote and therefore had to go forward. Councilor Dickinson commented this is a balancing act and much of this is out of the applicant's control. He feels we should follow the rules until we move away from them. Discussion ensued of exposing the town to liability. It may be time to review the policy, but the license cannot be issued until all requirements are met.

# Back to the vote on the motion. **President Trocki, Aye; Vice President Meagher, Aye; Councilor Dickinson, No; Councilor White, Aye; Councilor Tighe, No. Motion passes by a majority vote in the affirmative.**

President Trocki would like the Council notified when all conditions are met. Town Administrator Nota confirmed this will be reviewed and all conditions met prior to issuance of the license. Discussion ensued of the reasons for the delays that caused the non-compliance and lack of signatures for the application.
