#### JAMESTOWN CODE OF ORDINANCES

#### Chapter 70 – Traffic and Vehicles Article IV. Stopping, Standing and Parking

#### Sec. 70-94. Designation of residential parking streets.

Through a public hearing, the Town Council may designate a street within a residential parking district as a residential parking street, provided a petition in a form suitable to the town clerk has been filed that has been signed by residents representing at least fifty-one (51) percent of the resident households with an address of the specific street within the residential parking district requesting designation as a residential parking street.

## MEMORANDUM TO: Honorable Town Council

SUBJECT: Town Clerk Confirmation by Town Council Meeting on July 1, 2021

In the past few months this office has been working on filling the vacant position of Town Clerk. The process began in March/April when we advertised the position several times, in various venues as a result we received thirteen applicants in total.

Christina Collins, Aileen Flath and I reviewed the applications and determined five met the minimum qualifications. Upon concluding the first round of interviews, Ms. Collins and I determined three were qualified and we would interview those three for a second time.

The second interview team also included Town Clerk Arlene Petite (Retired) and Deputy Town Clerk Karen Montoya. After careful consideration we selected Roberta Fagan for the position. Ms. Fagan has a Bachelor's Degree from the University of Rhode Island in Sociology and History as well as an Associate's Degree in Applied Mortuary Sciences from the Funeral Institute of New England. Since 2005 to the present, she has served as an Assistant Director and then Executive Director with her professional experience including extensive office management, supervisory responsibilities, operations management, legislative compliance, advocacy and lobbying.

It is with great pleasure that I recommend to the Town Council, Roberta J. Fagan of Jamestown as our new Town Clerk. With your affirmation, this appointment is conditional upon Roberta becoming a Certified Municipal Clerk within three years of the course availability. Also, Roberta will begin on or about August 9<sup>th</sup> as she transitions from her current employment responsibilities.
